#### **1. Introduction**

The Summer School provides master level students with an in-depth exposure to the way leading management consulting firms are developing digital transformation projects in order to be better prepared for a future career in management consulting.

#### **2. Eligibility Criteria**

In order to be admitted to the selection students must be regularly enrolled to the MSc in Business Administration;

#### **3. Selection**

The selection of candidates will be based on:

- the performance during the MSc in Business Administration in terms of marks and credits obtained (GPA).

In order to calculate the GPA, the Examination Board will consider the student's marks and his/her extra-activities that appear on the Delphi system on the date of the deadline for submitting applications. In case of incomplete information (i.e. the exams or extra activities are not registered yet), the students may attach a copy of their booklet (libretto) and/or possible documents issued by the University assuring the absolute completion of undertaken exams and extra-activities.

- the Curriculum vitae;
- the motivation letter.

#### **4. Application**

- The application form;

- Academic transcript ( self-declaration);
- Motivation letter

One missing element will affect the applicant’s eligibility.

Candidates’ evaluation will be carried out by an Examination Board appointed by the School of Economics, Department of Management and Law.

### **5. Expenses**

The Master of Science in Business Administration will cover the participation fee and subsistence expenses, not any travel cost.
