The Master of Science in European Economy and Business Law (EEBL MSc), entirely taught in English, intends to train students to work with a competitive advantage in the field of economics, European institutions management, and market regulation. Through a solid preparation in the field of Economics and Law and by adopting interdisciplinary and interactive teaching methods, the programme aims at developing advanced knowledge and critical ability. This Master of Science will provide students with competences to play an active role within the European institutional system and skills to acquire an in-depth insight of institutional players in the European Union.

## **COURSE STRUCTURE**

The EEBL MSc is a two-year programme (4 semesters/120 ECTS), based on nine core courses and two optional courses. Students will also be required to acquire credits in extra activities (internship, cycle of seminars or Language Certificates) and write a final thesis. During their third semester, students will be supported in finding an internship in Italy or abroad.

# **FEES**

The EEBL MSc annual fees consist of the **annual tuition fee of €2,500** (to be paid in two installments) plus **Italian university taxes whose amount depends on the family's income** (between € 462,12 - € 1,762.85 in the a.a. 2013-14).

**LAZIODISU (Student welfare agency)**: Admitted students can apply at LazioDisu for a € 4.901,22 scholarship and accommodation. In the past years more than 50 students/year received such scholarship.

## **COURSES TIMING**

Courses start on the third week of September 2014. The first semester ends before the Christmas holidays. The second semester starts at the beginning of March and ends at the end of May. Exam sessions are in January and February (winter session), in June and July (summer session) and in September (autumn session).

On the basis of the Admission Board decision, students without a background in Economics could be obliged or strongly encouraged to attend introductory courses (not for credit). These precourses will take place prior to the official start of the programme on the first week of September. They aim at providing a review of foundational concepts and some common basics for students entering the EEBL MSc.

#### **ADMISSION REQUIREMENTS**

- Undergraduate degree for Italian degree holders, a three-year undergraduate degree by 31st December 2013 or have acquired a postgraduate degree (vecchio ordinamento – prior to D.M. 509/99); for international applicants, an undergraduate degree, or a foreign degree deemed equivalent by the Admission Board;

- Personal skills and adequate undergraduate academic background, with specific reference to the fields of Economics and Law.

- Good knowledge of the English language is required, both written and spoken. A board appointed by the Department will check whether the applicants satisfy the admission requirements on the basis of their curriculum and personal background. The applicant's suitability for the EEBL Msc is evaluated through the information included in his/her dossier within her/his overall profile, experience, previous academic performance: to this end, exams, curriculum vitae and motivation letter by the student are taken into high consideration. On this basis students, may be admitted, or admitted under condition of participation to pre-courses offered by the Department, or under condition of debts (debiti fomativi), or not admitted at all.

#### ADMISSION PROCEDURE

The deadlines for the application are: 10<sup>th</sup> July 2014 (for Non-EU applicants); 20<sup>th</sup> September 2014 (for EU applicants); 31<sup>st</sup> August 2014 for EU applicants without background in economics.

Applicants are required to fill in the on-line application form and upload all the required documents listed below. Notice that only complete applications will be evaluated by the Admission Board.

List of required documents:

1) Transcripts Student record (translated in English) including exams passed and marks in the undergraduate degree as well as any other postgraduate programmes. Please include a table explaining the grading system used in your University indicating the minimum and maximum

achievable scores. The undergraduate GPA and transcripts are an indication of previous academic performance;

2) Curriculum Vitae in English (any format). The Admission Board will evaluate the information included in the CV and verify the applicant's overall profile, experience and knowledge;

3) Personal statement (in English, any format);

4) Reference letter from one referee. Once the contact details of the referee are inserted, the system will automatically send out a request to the referee to upload the reference letter. The referee has to follow the instructions in the automated reply.

Within three weeks after submission of a complete application package applicants will be informed by e-mail with an admission decision.

After receiving the Conditional Admission letter, the successful international applicants are asked to complete the pre-enrolment procedure in order to receive the formal Admission letter.

### **PRE-ENROLMENT**

#### **PRE-ENROLMENT - For International Students**

**EU nationals and EU-equated citizens** do not need a Visa to study in Italy. However, they do need to contact the competent Italian Diplomatic Authorities for the legal translation and the legalisation of the qualification.

Non-EU applicants are asked to contact the competent Italian Diplomatic Authorities in their home-country to complete the pre-enrolment procedures. Prospective students are advised to contact the aforesaid authorities for detailed information.

All admitted candidates who have studied in a non-Italian University must acquire "Dichiarazione di Valore" in loco (Declaration of Value), which is the official document our Administration requires for the enrolment.

Applicants have to apply for "Dichiarazione di Valore" at the Italian Embassy/Consulate in the country in which the Diploma was issued.

Applicants are required to send a scanned copy of the "Dichiarazione di Valore" as an e-mail attachment to the Admission Office (e-mail: study.in.english@economia.uniroma2.it) in order to get the formal Admission Letter which is required to get formally enrolled at Tor Vergata University. Non-EU prospective students will need the formal Admission Letter also for their visa application and, once in Italy, for the stay permit application.
