Course Description

The course aims at stimulating students to analyze and critically evaluate the main global economic issues and their impact on individuals, companies and public institutions. A non-exhaustive list of the topics covered in the course includes: competitive markets and market failures, national and transnational production, labor market and migration, international trade, growth, inflation, money and finance, macro and microeconomic policy.

Teaching Method

A wide variety of formal and practical teaching techniques and material will be used, with a strong emphasis on the interaction between teachers and students in class.

Assessment

The final exam consists of a written and an oral part. During the course, there will be one mid-term exam. Students who pass the mid-term, may sit the oral exam directly during the Summer session.

Students who turn down the mid-term result or who do not pass/take it, will have to take a final written exam prior to the oral exam.

Mid-term results remain valid for the second exam of the Summer session only if the student turns down his/her grade after the oral exam, not if he/she fails it. In this case he/she will have to take a final written exam again in order to be admitted to the oral exam in the second summer sessions. Students who take the exam in the autumn session will take both final written and oral exam.
