# THE PROGRAMME



The Master of Science in Business Administration (laurea magistrale - LM 77 Scienze economico-aziendali) is a two-year programme entirely taught in English, which is designed for students interested in a training programme on advanced topics related to Business Management and who wish to pursue an international career. The programme objective is to develop managerial skills, providing students with the necessary tools to operate in key areas of companies and allowing them to adapt to the rapid technological context changes that characterise the corporate world.

The programme has a strong international orientation: students from different countries, course content based on leading international cases, and regular presence of international partners and professors from various prestigious universities.

**Career opportunities:** The topics covered by the Master of Science in Business Administration are strategic issues for both business and public or private institutions. The structure of the Master's programme allows students to specialise in one thematic focus area that will usually determine their later career choice or to opt for a more general learning path.

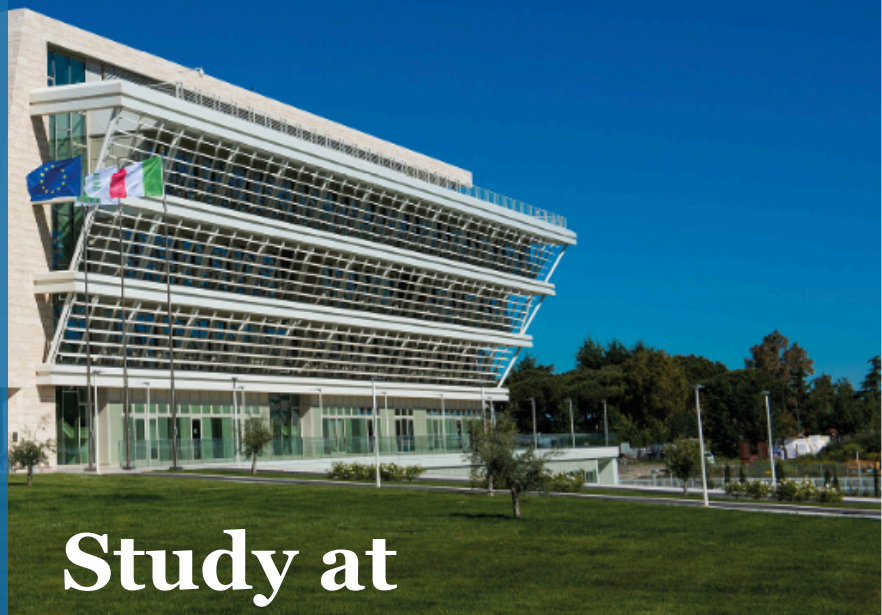

## Meet the requirements

**1** A three-year undergraduate degree, with a grade equal to or above 80% for international degrees and a grade equal to or above 88/110 for Italian degrees belonging to the course classes L-16 Administration and Organisation Sciences L-18 Economics and Management L-33 Economics.

For undergraduate degrees not belonging to the course classes mentioned above or not considered equivalent, the student must have obtained, by the date of the application, a total amount of 48 ECTS credits in specific scientific-disciplinary sectors.

**2** Certified knowledge of the English language at B2 level (Common European Framework). The list of certificates is available at: <https://economia.uniroma2.it/master-science/ba/new-intake/>

No English proficiency certificates are required from applicants who are active citizens of countries where English is one of the official languages and/or from applicants who have been awarded undergraduate degrees from Institutions where the programme has been taught in English.



## Admission procedure

The admission procedure consists of an online application to be completed with all required information and documents. Candidates will be notified of the Admission Board's decision by e-mail.

## Enrolment procedure

The enrolment procedure is available on the Delphi portal from late August to November.

Non-EU candidates requesting for a Study Visa, must apply for pre-enrolment through the UNIVERSITALY portal ([www.universitaly.it](http://www.universitaly.it)) from March to July and then contact the diplomatic-consular Representation in their country to provide the documents required for the visa to be issued. Tor Vergata University of Rome has set the level of tuition fees for degree programmes according to the principles of equity, progression and progressivity, in order to guarantee the right to study and to reward commitment and performance

Tuition fees are calculated on the basis of the economic situation of the student or his/her family, the degree programme and the ECTS credits earned.

The amount may vary from a minimum of 156€ to a maximum equal to 5,250€.

The economic situation is declared in the ISEE-U or ISEE parificato (for students whose income and assets are held abroad).
