# CALL FOR APPLICATION A.Y. 2018-2019 RESERVED TO SECOND YEAR STUDENTS BACHELOR COURSE IN "BUSINESS ADMINISTRATION & ECONOMICS" DUAL DEGREE PROGRAM UNIVERSITY AMERICAN COLLEGE OF SKOPJE

#### 1. Bilateral Agreement

- The University of Rome Tor Vergata and the American University College of Skopje have agreed on a Dual Degree Program for the bachelor course in Business Administration & Economics. According to the agreement, ten students of the Bsc in Business Administration & Economics will attend the third year at the School of Business Economics and Management, of the American University College of Skopje, obtaining the dual-title degree.
- Students wishing to apply to the Double Degree programme are invited to participate to this call.

# 2. Courses at the University American College of Skopje (UACS) to be completed in order to be awarded the Double degree:

The selected students must complete at least 48 CFU in order to be awarded the Double degree, otherwise the students will not be awarded the Double degree but the exams will be recognised.

#### 3. Criteria for eligibility:

- Being fully enrolled in the a.y. 2017/2018;
- Have a minimum grade of 25/30 in Mathematics exam;
- Have a minimum of 105 CFU within August 10.

NB: Winner students will be accepted "CON RISERVA", in accordance with the completion of the 105 CFU to be reached within August 1.

#### 4. Selection

The selection of candidates will be based on:

- The performance during the Bachelor in Business Administration & Economics, determined by marks' exams and Professors' opinions of the courses attained until the application for the Dual Degree Program.

Application has to be sent by February 28, 2018 to <u>silvia.tabuani@uniroma2.it</u> and in cc to segreteria@def.uniroma2.it, with subject "BAE – Dual Degree Application", and must include:

- Filled request form;
- A copy of the ID;
- Transcript of records (a self-declaration is fine).

One missing element will affect the applicant's eligibility.

Candidates' evaluation will be carried out by an Examination Board appointed by the Department of Economics and Finance and the Department of Management and Law.

WARNING: in accordance with the art. 71 of the Presidential Decree 445/2000, the Administration will proceed to undertake necessary checks, even sample checks, for any case showing reasonable doubts about the veracity of the statements certified by candidates on their application form.

#### 5. Credits for the Undertaken Activity

Before departure, it is imperative that the student signs the learning agreement so that exams taken at the Host Institution can be recognized.

#### 6. Assignation and Acceptance of the grant

The list of selected students will be published on the Department in Economics and Finance website, in the section Call for Application (*Bandi*) and in the Business Administration & Economics website.

This publication will be the only mean of disclosure of responses on the selection. No other written communication will be sent out to the selected students.

**PLEASE NOTE** that students have 30 consecutive days from the issue of the aforementioned list to accept the grant by showing up at the Business Administration & Economics Programme Office (Via Columbia 2 – Building B, I floor, room 1A.07) to sign the acceptance form. It will also be possible to send via email the aforementioned form to <a href="mailto:silvia.tabuani@uniroma2.it">silvia.tabuani@uniroma2.it</a>.

Formal acceptance is conditional in order to benefit from it. In the event of non-acceptance or exclusion from the competition, the latter will go to the next student of the list.
