- three reserved for 1st year students, to the amount of 2.900,00 euros each one;
- three reserved for 2nd year students, to the amount of 2.500,00 euros each one;

MINUTES OF THE EVALUATION MEETING

The Commission in charge of the above-mentioned selections, nominated by Directorial Decree No. 81/2016, is composed of:

- President: Prof. Leonardo Becchetti, full Professor of the University Tor Vergata;
- Member: Prof. Barbara Annicchiarico, associate Professor of the University Tor Vergata;
- Member: Dr. Claudio Auria, Adm. Secretary of this Dept./ University Tor Vergata Cat. EP.

The evaluation meeting takes place on February 2, 2017 at 16:00 at the Department of Economics and finance (DEF).

Dr. Claudio Auria assumes the role of the reporting secretary.

First of all the Commission, having examined the current legislation concerning the performance-based refunds to students, declares that there are no family relationships, up to the fourth-degree included, as well as other situations of incompatibility under articles 51 and 52 c.p.c., both among the members of the Commission itself and among them and the applicants to the above- mentioned selections.

In addition, the Commission, having examined the notice, restates the evaluation criteria and procedures published on the website of the Department on October 25, 2016, which are reported below:

- a) regarding 1st year students, the refunds are awarded to those students, who have achieved the best performance in the a.y. 2015/2016. The evaluation process is based on exams passed and recorded by September, 17th 2016 (Fall Session closing date), and on any other formative experience gained during the same period. In case two or more students are equally qualified, the refund will be awarded to the younger one;
- b) regarding 2nd year students, the refunds are awarded to those students, who have achieved the best performance in the last two academic years (2014/2015 and 2015/2016). The evaluation process is based on exams passed and recorded by September, 17th 2016 (Fall Session closing date), and on any other formative experience gained during the same period. In case two or more students are equally qualified, the refund will be awarded to the younger one.

The Commission introduces a minimum number of exams in addition to the above-mentioned criteria, as corrective measure for a fairer evaluation of academic performance. Therefore, it establishes to accept only the applications from those students who have passed at least 4 (four) exams for the first year and at least 8 (eight) exams for the second year. In addition, the Commission establishes the following priority order: in the first place, it will be considered the weighted average with reference to the exams passed within the above-mentioned term and, in the second place, any other formative experience gained during the same period of study.
