Development Economics (36 hours, 6 ECTS)

The gross amount includes the compensation for preparation activities, teaching activities, assistance to students and evaluation of students' learning related to the taught subjects (Ministerial Decree 21.07.2011 n.3). Exam setting and marking must be undertaken for all the three exam sessions of the academic year. The teacher will have two office hours a week during the course and will be available for clarifications by email during the whole year. Course content, assessment method and teaching schedule will be agreed with the Coordinator of the Msc in Economics Program. The course will run for 6 weeks, 6 hours a week.

The withholding taxes set by current regulations will be deducted from the gross amount at the expenses of the selected candidate.

The total cost (gross amount plus charges at the expenses of the Administration) will be borne by the funds of the Department of Economics and Finance for Master degree courses in Economics, European Economy and Business Law and the MESCI Master.
