**NOTICE OF THE SELECTION OF STUDENTS BA&E FOR BLENDED INTENSIVE PROGRAM**

**A.A. 2024/2025**

**Deadline for submitting applications: August 5<sup>th</sup>, 2025**

**Art. 1 – PURPOSE OF THE NOTICE AND AVAILABLE SCHOLARSHIPS**

In order to support internationalization it is announced in the academic year. 2024/2025, at the Department of Economics and Finance of the University of Rome Tor Vergata, a selection for the assignment of n. 15 available spots for the Blended Intensive Program in “Cultural Heritage and Tourism Investment Development”.

Students will not receive a scholarship but the participation fee will be waived.

**Art.2 – ADMISSION REQUIREMENT**

Students who meet one of the following requirements can participate in the selection:

- Student enrolled in the academic year 2023-2024 and currently enrolled in the second year of the three-year degree course in Business Administration and Economics, who have achieved the 100 credits required by the study plan relating to the exams as of 20 July 2025
- Student enrolled in the academic year 2022-2023 and currently enrolled in the third year of the three-year degree course in Business Administration and Economics who have achieved at least the 160 credits required by the study plan relating to the exams as of 20 July 2025
- Student enrolled before the academic year 2022-2023 and currently enrolled in the third year of the three-year degree course in Business Administration and Economics who have achieved at least the 160 credits required by the study plan relating to the exams as of 20 July 2025

**Cases of exclusion**

The following are excluded from the selection referred to in this announcement:

- students who have previously received sanctions following the submission of false declarations aimed at obtaining benefits for the right to education or for whom a disciplinary sanction has been imposed;
- students who have broken the code of ethics;
- all those who do not comply with the previously mentioned admission requirement.

**ART. 3 – PARTICIPATION IN THE COMPETITION AND APPOINTMENT OF THE COMMISSION**

To participate in the selection referred to in this announcement, graduates must submit a formal application by 5 August 2025, necessarily using the appropriate form (Annex A) attached to this announcement which, under penalty of exclusion, must:

- report the requested personal data;
- be signed by the applicant;
- be accompanied by a self-declaration necessary for the enrolment to the BIP (Annex B);
- be accompanied by the personal data processing form (Annex C);
- be accompanied by a copy of a valid identification document as well as the list of exams taken, with weighted average, using the Delphi extract.

The application to participate in the competition must be sent exclusively using the following link <https://forms.office.com/e/DGd6J5ejuh> Otherwise the Department will not consider the application.

The Commission responsible for the selection will be appointed by the Director of the Department, with his own decree, and will be composed, in addition to the President, also of two other members including the secretary taking the minutes.

#### **ART. 4 – AWARD CRITERIA AND MERIT RANKING**

The evaluation of applications is based on the results achieved by graduates from the moment of enrollment in the three-year degree course in Business Administration and Economics until 30 April 2025.

The evaluation criteria will be as follows:

When drawing up the merit ranking, the following formula will be used:

$$Score = 100 \times \left( \frac{ECTS\ earned}{Max\ ECTS\ on\ the\ basis\ of\ the\ enrollment\ year^*} \right) \times \left( \frac{Weighted\ average\ of\ exams\ taken}{30} \right) \times \min \left( 1, \frac{Length\ of\ the\ program}{N^o\ of\ years\ from\ enrollment} \right)$$

\* The number of max ECTS by year is set equal to 120 for the second year and 180 for the third year.

In case of a further ex aequo position, the date of the last exam will be considered and the student who was able to complete all the exams first will prevail.

In the event of a further ex-aequo position, the date of birth will be evaluated, and the younger student will prevail.

If some of the spots will be not assigned, there will be no additional selection procedure.

The merit ranking, with the appropriate guarantees to protect privacy, will be published on the website of the Department of Economics and Finance.

The publication of the ranking will be valid in all respects as official communication of the results. No other form of communication of the ranking is foreseen.

**The publication of the ranking is scheduled to start from 10 August 2025 and will continue for fourteen days.**



## ART. 5 – APPLICATION REQUIREMENTS

Candidates who have already completed an Erasmus mobility period abroad during their three-year degree program for a duration of 12 months or more are not eligible to participate in the selection process. The absence of this exclusion clause will be subject to self-certification, as shown in Annex A.

## Art.6 – PERSONAL DATA PROCESSING
