#### 1. Introduction

Students will have the opportunity to present their CV (both before and during the summer school) to leading consulting companies for internship opportunities.

#### 2. Eligibility Criteria

In order to be admitted to the selection, students must be regularly enrolled to the 2019-2020 academic year, to the one of the following Schools, at the University of Rome Tor Vergata:

- School of Economics
- School of Engineering
- School of Mathematics, Physics and Natural Sciences

## 3. Selection

The selection of candidates will be based on:

- the performance during the MSc in terms of number of credits and marks obtained (weighted average).
- In order to calculate the GPA, the Examination Board will consider the student's marks and his/her extraactivities that appear on the Delphi system on the date of the deadline for submitting applications. In case of incomplete information (i.e. the exams or extra activities are not registered yet), the students may attach a copy of their booklet (libretto) and/or possible documents issued by the University assuring the absolute completion of undertaken exams and extra-activities.
- the Curriculum vitae
- the motivation letter

A good knowledge of the English language (at least B2) is a requirement for a fruitful participation the programme.

There will be a ranking by school and an overall ranking. The first 5 students from each school will be selected and then the remaining 5 scholarships will be assigned based on the overall ranking with all the remaining candidates.
