Categories of personal data concerned</p>	<p>The University of Rome “Tor Vergata” processes the following categories of personal data:</p> <ul style="list-style-type: none"> • Personal data: name and surname, contact details, national identity card or passport, registration data, university carrier related data comprising marks and credits obtained (GPA), academic transcript, curriculum vitae, motivation letter, images. <p>The University undertakes not to process special categories of personal data (art. 9 G.D.P.R.) neither personal data relating to criminal convictions and offences (art. 10 G.D.P.R.).</p>
<p>3. How we collect information</p>	<p>Personal data are collected by the data subject at the time of the application.</p>
<p>4. Purposes of data processing</p>	<p>The purposes for which University of Roma “Tor Vergata” collects mandatory personal data are connected to the selection procedure of the MSc students who apply for the Yerun Summer School, as well as the subsequent management of the enrolled student carrier.</p> <p>The legal basis of the abovementioned treatment is referable to the art. 6, par. 1, lett. c) (“compliance with a legal obligation to which the controller is subject”), in accordance with the institutional guidelines of the University.</p>

Categories of recipients who may receive your personal data.</p>	<p>In addition to all the University personnel acting for the above mentioned purposes, personal data can be disclosed to third parties (public and private) in order to correctly fulfil the mentioned purposes, within academic relationships, in performance of law, regulations and contract obligations:</p> <ul style="list-style-type: none"> • M.I.U.R. (Ministero dell’Università e della Ricerca) for the fulfillment of the applicable laws; • Avvocatura dello Stato, Ministry of Foreign Affairs (Ministero degli Affari Esteri), Police Headquarters (Questure), Embassies, Procura della Repubblica regarding residence permits and visa or the recognition of particular status; • Insurance Institutions and INAIL (Istituto Nazionale per l’Assicurazione contro gli Infortuni sul Lavoro); • Public and private bodies (foundation, associations, companies, etc.) for the evaluation, recognition and attribution of economic benefits; • Other public or private subjects to whom the University of Rome “Tor

Data retention period (storage limitation)	<p>Once you enrol to the Yerun Summer School, University of Rome “Tor Vergata” will store your personal data in line with the student data retention policy. Where an item of your data no longer requires to be stored, it will be securely removed from our systems. Please note that if you enroll as a student of The University of Rome “Tor Vergata”, some items of your personal data will be stored on a permanent basis in order to ensure that the University can maintain a permanent archive of degrees and credit awarded and provide services to graduates/former students.</p>
7.
