BLENDED PROGRAMME "Sustainable Public Procurement in the Digital Age"

RESERVED TO MASTER OF SCIENCE DEGREE STUDENTS - 10 positions

1. Introduction

The Blended Programme on "Sustainable Public Procurement in the Digital Age" aims to provide masterlevel students with hints and a direct engagement on how public procurement can be redesigned through digital tools to achieve sustainability goals.

Entirely taught in English, the programme will start with a self-paced module open from May 15th. It will be centered on an on-site week from **July 10th to July 14th 2023** and will see its closure by July 28th with an online presentation of the groupwork results.

2. Eligibility Criteria

In order to be admitted to the selection students must be regularly enrolled to the MSc in Business Administration.

3. Selection

The selection of candidates will be based on:

- the performance during the MSc in Business Administration in terms of marks and credits obtained (GPA). In order to calculate the GPA, the Examination Board will consider the student's marks and his/her extraactivities that appear on the Delphi system on the date of the deadline for submitting applications. In case of incomplete information (i.e. the exams or extra activities are not registered yet), the students may attach any document issued by the University/Professors assuring the completion of given exams or extra-activities. - the Curriculum vitae;

- the motivation letter.

4. Application

Applications must be sent by **May 8th 2023 at 13:00** to <u>managementediritto@pec.torvergata.it</u> and in cc to <u>info@proctogo.uniroma2.it</u> entering the following heading in the subject field "Blended programme", and must include:

- The application form
- A copy of the identity card or passport
- Curriculum vitae
- Academic transcript (self-declaration)
- Motivation letter



One missing element will affect the applicant's eligibility.

Candidates' evaluation will be carried out by an Examination Board appointed by the School of Economics, Department of Management and Law.

WARNING: in accordance with the art. 71 of the Presidential Decree 445/2000, the Administration will proceed to undertake necessary checks, even sample checks, for any case showing reasonable doubts about the veracity of the statements certified by candidates on their application form.

5. Expenses

The Master of Science in Business Administration will grant free participation to the course and will cover the accommodation in a double-room. Dinners are not included.

6. Assignation and Acceptance

The list of selected students will be published on the Management and Law Department's website in the section Call for Application (Selezioni e *Bandi*) after May 10th 2023.
