BLENDED PROGRAMME "AI-empowered Management Consulting"

RESERVED TO MASTER OF SCIENCE IN BUSINESS ADMINISTRATION STUDENTS - 10 positions

1. Introduction

The Blended Programme on "AI-empowered Management Consulting" aims to provide master-level students with hints and a direct engagement on how Generative AI is enriching the offering and transforming the way of working of Management Consulting companies.

Entirely taught in English, the programme will start with a self-paced module. It will be centered on an onsite week from **July 1st to July 5th 2023** and will see its closure by July 12th with an online presentation of the groupwork results.

2. Eligibility Criteria

In order to be admitted to the selection students must be regularly enrolled to the MSc in Business Administration.

3. Selection

The selection of candidates will be based on:

- the performance during the MSc in Business Administration in terms of marks and credits obtained (GPA). In order to calculate the GPA, the Examination Board will consider the student's marks and his/her extraactivities that appear on the Delphi system on the date of the deadline for submitting applications. In case of incomplete information (i.e. the exams or extra activities are not registered yet), the students may attach any document issued by the University/Professors assuring the completion of given exams or extraactivities.

- the Curriculum vitae;
- the motivation letter.

4. Application

Applications must be sent by **June 13th 2024 at 13:00** to <u>managementediritto@pec.torvergata.it</u> and in cc to <u>erasmus@economia.uniroma2.it</u> entering the following heading in the subject field "Blended programme", and must include:

- The application form here attached (filled in and signed)
- A copy of the identity card or passport
- Academic transcript (self-declaration)

One missing element will affect the applicant's eligibility.



Candidates' evaluation will be carried out by an Examination Board appointed by the School of Economics, Department of Management and Law.

5. Expenses

The Master of Science in Business Administration will grant free participation to the course.

6. Assignation and Acceptance

The list of selected students will be published on the Management and Law Department's website in the section Call for Application (Selezioni e Bandi) after June 14th 2024.
