ALL WINNER CANDIDATES must complete the ENROLMENT PROCEDURE from July 15th to July 30th, 2020. They will soon receive the procedure to follow by e-mail.

Winner candidates who will not respect the on-line enrolment deadline, will leave their positions to the following eligible candidates.

Regarding this, the **total merit ranking scrolling** will be published on our website <https://economia.uniroma2.it/ba/business-administration-economics> on **August 5th, 2020.**

Winner candidates resulting from this scrolling process will have to complete the on-line enrolment procedure **from September 3rd to September 24th, 2020.**

DETAILS FOR STUDENTS WITH FOREIGN QUALIFICATION

Foreign qualification at the time of the enrolment in any Italian University **MUST** be provided with the related official legalization/apostille, italian translation and **Declaration of Value (D.O.V.)** issued by the Italian Diplomatic Representative in the Country in which the diploma has been obtained.

Alternatively, students can provide the **Statement of Comparability** issued by [CIMEA](#) (which is a suitable substitute for the above-mentioned required documents).

The University of Rome Tor Vergata and CIMEA have made an agreement for the issuing of the Statement of comparability for final school and university qualifications obtained abroad.
