**NOTICE**  
**FOR THE AWARDING OF N. 3 STUDENT PRIZES**  
**FOR STUDENTS ENROLLED IN THE MASTER OF SCIENCE IN ECONOMICS IN THE**  
**2020/2021 ACADEMIC YEAR**  
**(With reference to the DEF Council Resolution of 13.10.20)**

**Art. 1 – Purpose of the notice and the available awards**

The Department of Economics and Finance at Tor Vergata University of Rome announces a selection for the awarding of n. 3 student prizes for the gross amounts of €1.500, €1.000 and €500 euro (before tax withholdings required by law) to students enrolled in MSc Economics who meet the following criteria:

- a) They enrolled as a first year student of the Master of Science in Economics in the 2019/2020 academic year;
- b) They are regularly enrolled as a second year student of the Master of Science in Economics in the 2020/2021 academic year;
- c) They have passed, by 30-09-2020, all exams and activities foreseen in the first year of study of the 2019/2020 academic year.

**Cases for exclusion** - The following candidates will be excluded from the present selection:

- Students who have previously received sanctions following the presentation of false declarations aimed at obtaining benefits for the right to study or for which a disciplinary sanction has been issued.
- Students who receive a scholarship, prize, grant, monetary contribution or other benefit from the University during the 2020/2021 academic year.
- Students who do not meet the selection criteria indicated in Art. 1 of the present notice.



**Art. 2 – Participation in the call for applications, selection criteria and the evaluation committee**

To participate in the selection referred to in this notice, students will not be required to submit a formal application, as the ranking will be drawn up with the data in possession of the Delphi database. In particular, the ranking will be formulated on the basis of objective criteria which is the weighted average of the marks for the respective CFU of all first year exams in accordance with the Degree Program that were achieved by 30/09/2020. In the event of an equal ranking position, the number of credits will be taken into consideration. In the event of continued equal ranking, the age of the students will be taken into consideration and the youngest candidate will be favoured.

The top three ranking students will be assigned the scholarship.

*Please note: For the purpose of candidate evaluation, only exams taken at the University of Rome Tor Vergata or taken as part of mobility programs will be considered. Recognized exams from other university careers will not be considered.*

**Art. 3 – Evaluation committee**

The selection committee will be appointed by decree of the Department Director and will be composed of three members including the recording secretary.

**Art. 4 – Publication of the candidate ranking**

The merit ranking will be published on the website of the Department of Economics and Finance (<https://economia.uniroma2.it/def/archivio-selezioni-e-bandi/>) and on the MSc Economics website (<https://economia.uniroma2.it/master-science/economics>) by 30 January 2021. The publication of the ranking will be valid in all respects as an official communication of the results.

**Art.5 – Prize accumulation policy notice**

The monetary prize of the scholarship cannot be awarded if other scholarships, prizes or incentives have been granted by the University during the same academic year. The student must therefore indicate under his/her direct responsibility that he/she has not already benefitted from another scholarship, award or contribution granted by the University for the same academic year. If at a later time, the candidate is a recipient of another award for the 2020/2021 academic year, he/she must immediately send notification to both of the following email addresses: [segreteria@def.uniroma2.it](mailto:segreteria@def.uniroma2.it) and [msc\\_economics@economia.uniroma2.it](mailto:msc_economics@economia.uniroma2.it), specifying which scholarship prize he/she intends to keep.

PLEASE NOTE: If the winner's notification to forfeit the prize arrives after the payment of the scholarship prize, the student must return the amount received.

Within 5 days of receipt of the aforementioned communication, the winner must accept the study prize, otherwise the student will be considered as forfeiting the prize and the ranking will be scrolled.

To accept the prize, the following documentation must be sent to both email addresses [msc\\_economics@economia.uniroma2.it](mailto:msc_economics@economia.uniroma2.it) and [segreteria@def.uniroma2.it](mailto:segreteria@def.uniroma2.it):

- Italian tax ID number (*codice fiscale*), dated and signed by student;
- Valid ID, dated and signed by student;
- Annex A, declaration to substitute certification, duly filled out and including the IBAN of the bank account in the name of the winning student (BIC and SWIFT if applicable), signed by student;
- Annex B, declaration to substitute certification in reference to the cases of exclusion indicated in Art. 1, signed by student;
- Annex C, declaration to substitute certification in reference to regular enrolment in MSc Economics;
- Annex D, privacy policy disclosure, signed by student.

The University reserves the right to check the correctness of the declarations submitted.
