CALL FOR APPLICATION FOR THE ASSIGNMENT OF N. 3 MERIT PRIZES TO THE BEST FIRST YEAR STUDENTS OF THE MSC IN ECONOMICS

Deadline 19 November 2017

Art. 1 – Purpose of the Call for Application and Awards

The Department of Economics and Finance of the University of Rome Tor Vergata announces a selection for the award of n. 3 Merit Prizes to students enrolled in the 1st year of the Master of Science in Economics in the a.y. 2016/2017, as follows:

- N° 1 prize of 3.000,00 euros (gross) will be awarded to the student who has achieved the best performance in the a.y. 2016/17;

- N° 2 prizes, of 500,00 euro each (gross) will be awarded to the students who achieved the second best and third best performance in the a.y. 2016/17.

Art.2 – Requirements

Requirements for participating to the selection:

- to be regularly enrolled to the second year of the Master of Science in Economics in the a.y. 2017/2018;

- to have been enrolled to the first year of the Master of Science in Economics in the a.y. 2016/17;

- to have undertaken all the exams and "idoneità" for the first year of the study plan by the 31 October 2017;

- to have undertaken all the exams within the Master of Science in Economics, thus, they have not obtained the recognition for credits obtained at other Degree Courses.

Exclusion Cases

Are excluded from the selection:

- students who have previously received sanctions following the submission of false statements aimed at obtaining benefits for the right to study or for which a disciplinary sanction has been granted;

- students who have already received scholarships, grants and fundings for the academic year 2016/2017 in accordance with current legislation for study right, scholarships issued by other institutions or students who have benefited from other grants or exemptions from the payment of university fees granted by the University of Rome Tor Vergata.

<u>Note</u>: If the candidate qualifies for the same academic year of another scholarship or contribution after the award of the grant mentioned in this notice, he/she must immediately notify the secretariat of the department <u>segreteria@def.uniroma2.it</u>

ART. 3 – How participate to the selection, selection criteria and Committee

To participate to the selection, the students who are in possession of all the requirements (see Art. 2) must submit the application using the form attached to this notice, which, by exclusion, shall:

- contain all the required data;

- be signed by the applicant;

- be accompanied by a copy of a valid Identity Document and the list of all passed exams with marks and media (use the Module attach to the application form).

Applications must be submitted by the 19 of November 2017, by email to <u>segreteria@def.uniroma2.it</u> and in cc <u>martina.spaziani@uniroma2.it</u>, with subject of the email **"Economics - MATRICOLE - candidatura premi di merito".**

The ranking, drawn up by the Committee, will be elaborated on the basis of the weighted average for the respective CFU of all the exams scheduled for the first year of the program and undertaken within the 31 of October 2017.

In case of equal merit the prize amount will be divided between the winners.

The Committee will be appointed by the Department's with his own decree and will be composed of three members including the verbalizing secretary.

ART. 4 – Final Ranking

The ranking, with the appropriate safeguards of privacy, will be published on the website of the Department of Economics and Finance.

The publication of the ranking will be the official announcement of the results. There is no other form of communication of the awards.

The ranking will be published by the 30 of November 2017.
