Decr. n. 88/2018 dated 15 November 2018 *CALL FOR THREE BEST STUDENT PERFORMANCE AWARDS RESERVED TO THE MSC in ECONOMICS STUDENTS* (Ref. Committee of the Department in Economics and Finance dated 09 October 2018)

Art. 1 – Best student performance award and admission requirements - The Department in Economics and Finance of the University of Rome Tor Vergata has launched the selection for the award of three scholarships, respectively of the ammount of 1.500,00 euro for the first ranking, 1.000,00 euro for the second ranking and 500,00 euro for the third ranking, paid in a lump sum (gross of tax law withholding taxes) to the students of the MSc in Economics who satisfied the following criteria:

- a) students must be regularly enrolled at the II year of the MSc program in Economics in the a.y. 2018/2019;
- b) students must have passed by October 15, 2018 all the exams and pass/not pass examinations included in the course structure of the I year of the MSc in Economics program a.a. 2017/2018 at this University;
- Cases of not eligibility The following students are considered ineligible from the selection:
 Students who have received penalties due to false statements aimed to achieve benefits of right to education or a disciplinary penalty.

• Students who already benefited, during the 2017/2018 A.Y, of scholarships, contributions, loans supplied in accordance with the current regulation about the right to education, scholarships supplied by other agencies or students who benefited of university fees' exemptions recognized by the University. If the applicant, after the assignment of the grant referred to this call, will be selected for another scholarship, must immediately communicate it by email to <u>segreteria@def.uniroma2.it</u> and <u>msc_economics@economia.uniroma2.it</u>.

• All students who do not sarisfied the requirements at art. 1

Art. 2 – Terms and conditions: Participation at the selection, Selection Committee and criteria- In order to participate at the selection of this call, students will not have to submit a formal request, since the list will be redacted taking into account merits and income data held by the University database.

The selection will be made evaluating the academic curriculum, based on the relation between the number of the credits accrued (in relation with the required credits) and the weighted average marks acquired within October 15, 2018.

Please note: Only the exams and relative marks taken at University of Rome Tor Vergata or abroad, within the framework of University of Rome Tor Vergata mobility programmes, will be evaluated. Exams from other academic carriers will not be recognized.

Art. 3 – Commission for evaluation - The Commission in charge for the selection will be directly named by the Director of the Department, through his decree. It will be formed by three members.

Art. 4 – **Merit List** – The merit list will be published on the Department and MSc in Economics website at the following address, under the appropriate guarantees to protect the privacy:

The publication of the list will be an official communication of the results.

Any other form of communication of the list is not provided.

The publication of the list is scheduled on November 30, 2018.

The final merit list will be published on the afrementioned websites just after the procedure described in the following Art. 5.

Art. 5 – **Conferral of the scholarship-** An e-mail will be sent to the winners (the e-mail address present in the Delphi system). Within 5 days of receipt of communication, the winner must accept the scholarship, otherwise it will be considered renounced and the ranking will proceed.

To accept the scholarship it is necessary to send by email at <u>msc_economics@economia.uniroma2.it</u> and <u>segreteria@def.uniroma2.it</u> the following

documents:

- copy of the fiscal code;

- valid identity document;

- Substitutive declaration of certification (Attachment A, here enclosed) duly completed, with the IBAN code of the current account held by the winner (in case of a foreign account, please specify the SWITCH Code).

- Substitutive declaration of certification (Attachment B, here enclosed) duly completed, with reference to the cases of not eligibility mentioned at art 1 of this call.

The University has the right to check the truthfulness of the information provided.
