A SMALL GROUP OF TALENTED STUDENTS

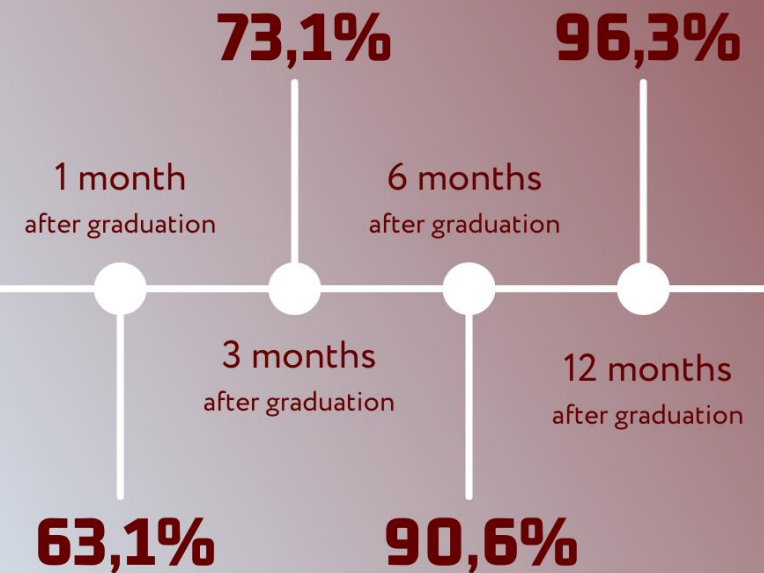
