**ANNOUNCEMENT OF COMPETITION FOR THE ASSIGNMENT OF N. 3 PROJECT PRIZES FOR STUDENTS ENROLLED IN THE MASTER'S DEGREE COURSE IN EUROPEAN ECONOMY AND BUSINESS LAW - EEBL (DEGREE CLASSIFICATION LM-90) AS AN INCENTIVE TO CARRY OUT TRAINING PROJECTS**

**2020/2021 ACADEMIC YEAR**

**Application deadline: 1 August 2021**

**Art. 1 – Purpose of the call and available scholarships**

In order to reward excellence, motivate academic commitment and promote participation in paid training initiatives, the Department of Economics and Finance of the University of Rome Tor Vergata announces a call for applications for the 2020/2021 academic year for the assignment of n. 3 project prizes for students enrolled in the Master of Science Degree Programme in European Economy and Business Law, each award amounting to € 500.00 (before tax withholdings required by law) according to the resolution of the Department Council on 11 May 2021 to students who successfully complete an onerous Training Project that is aimed at deepening the specialist knowledge offered by MSc EEBL and in line with the Programmes' educational objectives.

**Art.2 – Admission requirements**

Students who are regularly enrolled in MSc European Economy and Business Law (LM-90) in the 2020-2021 academic year and who are in good standing with the payment of university fees and contributions for the 2020-2021 academic year may participate in the selection.

PLEASE NOTE: In the event that exams have not yet been registered on the Delphi online system, it is necessary to indicate this in the application referred to in Article 3 below. The Commission referred to in Art. 3, at the time of the evaluation of applications will ask for a statement from the Professor certifying the completion of the exam and its evaluation.

**Cases for exclusion**

The following candidates will be excluded from the present selection:

- Students who have previously received sanctions following the submission of false declarations aimed at obtaining benefits for the right to study or for which a disciplinary sanction has been issued.
- Students who have infringed the code of ethics, and those who have been reported by professors or administrators as a result of inappropriate or illegal behaviour and received disciplinary sanctions.
- Students who have already benefited, in the current academic year, from scholarships, prizes, or other benefits and incentives granted by the University based on academic merit.
- All students who do not comply with the selection criteria previously indicated in Art. 2 of the present notice.

### **ART. 3 – Participation in the competition and the appointment of the commission**

To participate in the selection as per this announcement, students must present a formal application by 1 August 2021, using the appropriate form attached to this announcement, which, under penalty of exclusion, must:

- present all the requested personal data;
- be signed by the candidate;
- be accompanied by the privacy disclosure statement that is signed by the candidate;
- be accompanied by a valid ID, as well as by an updated list of exams taken and weighted GPA (Delphi exam certificate);
- include a one-page detailed description of the proposed training/education programme that the candidate plans on undertaking;
- include the letter of admission / registration confirmation should the candidate already be in possession of such documentation.

The project proposal (for example, for a summer school, internship, professional training or startup) should be in line with the learning objectives of the MSc European Economy and Business Law academic programme and be aimed at reaching a deeper understanding of specialist knowledge offered by the Programme. The detailed description of the proposed project should include the name and location of the organizing institution, the place of activity, the duration, the level of education / training and a complete description of the programme. In addition, the candidate should indicate his/her motivations for participation, explain the link to the topics presented in the EEBL academic programme and present the estimated expenses. Payment of the scholarship will be made upon presentation by the student of official documentation that attests the completion of the proposed project. Please note that the documentation must be submitted to the EEBL Programme Office prior to graduation.

The application for participation in the competition must be sent to both of the following email addresses: [msc@eebl.uniroma2.it](mailto:msc@eebl.uniroma2.it) and [segreteria@def.uniroma2.it](mailto:segreteria@def.uniroma2.it), by **1 August 2021**, and with the object of the email: **NAME + SURNAME – Application for EEBL Project Prizes**. Otherwise the Department reserves the right not to consider the application.

The selection committee will be appointed by Decree of the Department Director and will be composed of three members including the President and the recording secretary.

#### **ART. 4 – Evaluation criteria and candidate ranking**

The evaluation of the candidates is based on the academic results earned by the students from the moment of enrolment in MSc European Economy and Business Law until 19 July 2021. During the evaluation of each project proposal, in addition to the student's academic career, the student's state of health will also be taken into consideration and any existing disabilities, serious illness, pregnancy or maternity will be taken into account.

In drawing up the ranking, the Commission will take the following predominantly into account:

- the weighted average of the exams taken;
- the total number of credits earned by the student from enrolment up to and including the 2021 summer exam session;
- the quality of the proposed project.

In the case of an equal ranking among candidates, the amount of the last prize will be divided equally among the winners.

In the event that the prizes remain unassigned, there will be no new selection.

The merit ranking, with appropriate safeguards to protect privacy, will be published on the website of the [Department of Economics and Finance](#).

The publication of the ranking will be valid in all respects as an official communication of the results. There is no other form of communication of the ranking.

**The ranking will be published after 10 August 2021.**

#### **ART. 5 – Prize accumulation policy notice**

The contribution cannot be combined with other scholarships, prizes or other contributions granted by the University itself for the same academic year. If the candidate is an assignee for the same academic year of another award, scholarship or contribution, he/she may still participate in the present selection, indicating his/her circumstance in the application form referred to in Art. 3 and in the event that he/she is a winner, he/she must exercise the right of option, returning any amount already paid by the University, subsequent to the one referred to in this notice.

#### **ART.6 – Processing of personal information**
