ANNOUNCEMENT OF COMPETITION FOR THE ASSIGNMENT OF N. 3 PERFORMANCE PRIZES FOR STUDENTS ENROLLED IN THE MASTER'S DEGREE COURSE IN EUROPEAN ECONOMY AND BUSINESS LAW - EEBL (DEGREE CLASSIFICATION LM-90)

2019/2020 ACADEMIC YEAR

Deadline: 1 May 2020

Art. 1 – Purpose of the call and available scholarships

In order to reward excellence, motivate academic commitment and promote participation in paid training initiatives, the Department of Economics and Finance of the University of Rome Tor Vergata announces a call for applications for the 2019/2020 academic year for the assignment of n. 3 performance prizes for students enrolled in the Master of Science Degree Programme in European Economy and Business Law, each award amounting to € 500.00 (before tax withholdings required by law) according to the resolution of the Department Council on 17 March 2020. The merit award will be paid as a reimbursement of the expenses incurred for carrying for a Training Project that is both aimed at deepening specialist knowledge and in line with the educational objectives of the EEBL academic programme.

Art.2 – Admission requirements

Students who are regularly enrolled in MSc. in European Economy and Business Law (LM-90) in the 2019-2020 academic year may participate in the selection.

☐ Cases for exclusion

The following candidates will be excluded from the present selection:

- Students who have previously received sanctions following the submission of false declarations aimed at obtaining benefits for the right to study or for which a disciplinary sanction has been issued.
- Students who have infringed the code of ethics or have been reported by professors or administrators as a result of inappropriate or illegal behaviour.
- Students who have already benefited, in the current academic year, from scholarships, prizes, or other benefits and incentives granted by the University.
- All students who do not comply with the selection criteria previously indicated in Art. 2 of the present notice.

Please Note: If the candidate is awarded another scholarship or contribution for the same academic year after the awarding of the prize referred to in this announcement, he/she must immediately notify the Secretariat of the Department of Economics and Finance by sending communication to both of the following email addresses:

segreteria@def.uniroma2.it and msc@eebl.uniroma2.it. The candidate will be excluded from receiving the financial benefit of the present prize.

ART. 3 – Participation in the competition, selection criteria and the appointment of the commission

To participate in the selection as per this announcement, students must present a formal application, using the appropriate form attached to this announcement, which, under penalty of exclusion, must:

- present all the requested data;
- be signed by the candidate;
- be accompanied by the privacy disclosure statement that is signed by the candidate;
- be accompanied by a valid ID, as well as by an updated list of exams taken and weighted GPA (self-certification form);
- include a one-page detailed description of the proposed training/education programme that the candidate plans on attending and the letter of admission / registration confirmation should the candidate already be in possession of such documentation.

The project proposal should be in line with the learning objectives of the MSc. European Economy and Business Law academic programme and be aimed at reaching a deeper understanding of specialist knowledge. The detailed description of the proposed project should include the name of the institution, the place of activity, the duration, the level of education / training and a complete the description of the programme. In addition, the candidate should indicate his/her motivations for participation, explain the link to the topics presented in the EEBL academic programme and present the estimated expenses. Expenses to be considered valid are those sustained before the date of graduation. The reimbursement will be made upon presentation of original invoices and receipts of the expenses incurred.

The application for participation in the competition must be sent to both of the following email addresses: msc@eebl.uniroma2.it with segreteria@def.uniroma2.it in copy, by **1 May 2020**, and with the object of the email: **NAME + SURNAME – Application for EEBL Performance Prizes**.

By 1/05/2020, students must be:

- in compliance with the payment of university fees and contributions for the 2019/2020 academic year;
- in possession of all the requirements described and required by Art. 2 of the present announcement and the resolution of the Department Council of 17 March 2020.

The evaluation of the candidates will be carried out through the assessment of the academic curriculum, that is, by calculating the number of credits earned compared to those due and evaluating the weighted average of the marks achieved by 14 February

2020 and indicated in the University database. During the evaluation of each project proposal, in addition to the student's academic career, the student's state of health will also be taken into consideration and any existing disabilities, serious illness, pregnancy or maternity will be taken into account. Candidates who attach the certification of their current state of health with reference to the previously indicated personal issues will have a bonus point in the ranking.

In the case of an equal ranking among candidates, the amount of the last prize will be divided equally among those eligible.

The selection committee will be appointed by Decree of the Department Director and will be composed of three members including the recording secretary.

ART. 4 – Candidate ranking

The merit ranking, with appropriate safeguards to protect privacy, will be published on the website of the [Department of Economics and Finance](#).

The publication of the ranking will be valid in all respects as an official communication of the results. There is no other form of communication of the ranking.

The ranking will be published after 30 May 2020.

ART.5 – Awarding of the prize

The awarding of the prize is subject to the successful completion of the proposed project referred to in Art. 2 and the delivery to the MSc. EEBL Programme Office of the following original documentation by the date of graduation:


- Reimbursement request form;
