**ANNOUNCEMENT OF COMPETITION

Art. 1 – Purpose of the call and available awards

The Department of Economics and Finance of Tor Vergata University of Rome hereby announces a call for applications for the awarding of n. 2 prizes, of which one for €1.000,00 and one for €500,00 (before tax withholdings required by law), for students graduating by 31 October 2020 with a degree in MSc European Economy and Business Law.

Art.2 – Admission requirements

Students who meet the following criteria may participate in the call for applications:

- a) Students who enrolled in MSc European Economy and Business Law as first year students in the 2018/2019 academic year;
- b) Students who graduated with a degree in MSc European Economy and Business Law by 31 October 2020.

Cases for exclusion

The following candidates will be excluded from the present selection:

- Students who have previously received sanctions following the submission of false declarations aimed at obtaining benefits for the right to study or for which a disciplinary sanction has been issued.
- Students who have infringed the code of ethics or have been reported by professors or administrators as a result of inappropriate or illegal behaviour.
- Students who have already benefited, in the 2019/2020 academic year, from scholarships, prizes, or other benefits and incentives granted by the University.
- All students who do not comply with the selection criteria previously indicated in Art. 2 of the present notice.

Please Note: If the candidate is awarded another scholarship or contribution for the same academic year after the awarding of the prize referred to in this announcement, he/she must immediately notify the Secretariat of the Department of Economics and Finance by sending communication to both of the following email addresses: segreteria@def.uniroma2.it and msc@eebl.uniroma2.it. The candidate will be excluded from receiving the financial benefit of the present prize.

ART. 3 – Participation in the competition, selection criteria and the appointment of the commission

To participate in the selection as per this announcement, students who meet the necessary criteria indicated in Art. 2 must present a formal application, using the appropriate form attached to this announcement, which, under penalty of exclusion, must:

- present all the requested data;
- be signed by the candidate;
- be accompanied by the privacy disclosure statement that is signed by the candidate;
- be accompanied by a valid ID, as well as by an updated list of exams, weighted GPA and final grade of the Master of Science degree.

The application for participation in the competition must be sent to both of the following email addresses: msc@eebl.uniroma2.it with segreteria@def.uniroma2.it in copy, by **30 November 2020**, and with the object of the email: **NAME SURNAME – EEBL Graduate Prize application 2020**. Applications will be excluded from the selection if they are not sent as indicated in the present call.

The evaluation of the candidates will be carried out through the assessment of the academic curriculum, that is, the weighted average of the marks based on the number of credits earned for the foreseen exams, based on the information in the University database. During the evaluation of each candidate, in addition to the student's academic career, the student's state of health will also be taken into consideration and any existing disabilities, serious illness, pregnancy or maternity will be taken into account. Candidates who attach the certification of their current state of health with reference to the previously indicated personal issues will have a bonus point in the ranking.

In the case of an equal ranking among candidates, the prize will be awarded to the younger candidate.

The selection committee will be appointed by Decree of the Department Director and will be composed of three members including the recording secretary.

ART. 4 – Candidate ranking

The merit ranking will be published on the website of the [Department of Economics and Finance](#).

The online publication of the ranking will be valid in all respects as an official communication of the results. There is no other form of communication of the ranking.

The ranking will be published by 15 January 2021.
