CALL FOR APPLICATION A.Y. 2018/2019 RESERVED TO FIRST YEAR STUDENTS OF M.Sc. IN FINANCE AND BANKING DUAL DEGREE PROGRAMS - UNIVERSITY OF GOTHENBURG AND UNIVERSITY OF KOZMINSKI

-brief summary in English language of Decr. N. 10/2019 -

1. Bilateral Agreements

- The University of Rome Tor Vergata and the University of Gothenburg have signed a Dual Degree Program Agreement, which allows at most two students of the MSc in Economics of the University of Rome Tor Vergata to attend the second year at the School of Business, Economics and Law of the University of Gothenburg and obtain a dual degree from both universities subject to them meeting all the requirements of the dual degree program.
- The University of Rome Tor Vergata and the University of Kozminski have signed a Dual Degree Program Agreement, which allows at most two students of the MSc in Economics of the University of Rome Tor Vergata to attend the second year at the University of Kozminski, and obtain a Dual Degree from both universities subject to them meeting all the requirements of the Dual Degree program.
- Students wishing to apply to one or both Dual Degree Programs are invited to apply for this call.

The University of Rome Tor Vergata provides two scholarships of **2500 up to 4500 euros**, on the base of ISEE-University, for each selected student for the Dual Degree program at Kozminski University as contribution to the expenses related to international mobility, upon two conditions:

- successful **completion of the first year examinations (48 CFU)** by the beginning of lectures at the host University;
- **Learning Agreement** approval by the MSc Coordinator.

2. Criteria for eligibility

- Being regularly enrolled in the first year of the Master of Science in Finance and Banking in a.y. 2018/2019.

3. Selection

- The applicants selection will consider the performance during the Fall Term of the MSc in Finance and Banking in terms of marks and credits.
- To benefit from the Prize and be allowed to enroll on the Dual Degree program, selected students will have to obtain a minimum number of 48 ECTS before the beginning of the courses at the host University, and agree with the Coordinator the courses they will attend there.
