**CALL FOR APPLICATION FOR THE ASSIGNMENT OF N. 2 MERIT PRIZES TO THE BEST FIRST YEAR STUDENTS OF THE MSC IN FINANCE AND BANKING**

**Deadline 30 November 2018**

Its purpose is to provide information to foreign students. It has no legal value. The only official and legally binding source is the original Italian announcement.*

**Art. 1 – Purpose of the Call for Application and Awards**

The Department of Economics and Finance of the University of Rome Tor Vergata announces a selection for the award of n. 2 Merit Prizes reserved to students enrolled in the 2nd year of the Master of Science in Finance and Banking in the a.y. 2018/2019, on the bases of the academic performance in the previous academic year, 2017/2018.

Each prize consists of a maximum amount of euro 1.877,08, splitted as follows:

- 877,08 euro (1.000,00 USD) for the enrolment fee to the *Advanced Risk and Portfolio Management (ARPM) Bootcamp 2018* held in New York (USA) in mid August 2019;
- a maximum refund of 1.000,00 euro for the participation expences, on the basis of the receipts provided.

**Art.2 – Requirements**

Requirements for participating to the selection:

- to be regularly enrolled to the second year of the Master of Science in Finance and Banking in the a.y. 2018/2019;
- to have been enrolled to the first year of the Master of Science in Finance and Banking in the a.y. 2017/16;
- to have undertaken all the exams and "idoneità" (pass/fail examination) for the first year of the study plan by the 31 October 2018;
- to have undertaken all the exams within the Master of Science in Finance and Banking, thus, they have not obtained the recognition for credits obtained at other Degree Courses, intern or extern to the University of Rome Tor Vergata.

**Cases of not eligibility**

Are excluded from the selection:

- students who have previously received sanctions following the submission of false statements aimed at obtaining benefits for the right to study or for which a disciplinary sanction has been granted;
- students who have already received scholarships, grants and fundings for the academic year 2017/2018 in accordance with current legislation for study right, scholarships issued by other institutions or students who have benefited from other grants or exemptions from the payment of university fees granted by the University of Rome Tor Vergata.

## **ART. 3 – How participate to the selection, selection criteria and Committee**

To participate to the selection, the students who are in possession of all the requirements (see Art. 2) must submit the application using the form attached to this notice, which, by exclusion, shall:

- contain all the required data;
- be signed by the applicant;
- be accompanied by a copy of a valid Identity Document and the list of all passed exams with marks and weighted average (use only the official application form).

Applications must be submitted by November 30 2018, by email to [segreteria@def.uniroma2.it](mailto:segreteria@def.uniroma2.it) and [msc\\_finance@economia.uniroma2.it](mailto:msc_finance@economia.uniroma2.it) , with subject of the email "**Finance and Banking - MATRICOLE - candidatura borse di merito**".

The ranking, drawn up by the Committee, will be elaborated on the basis of the weighted average for the respective CFU of all the exams scheduled for the first year of the program and undertaken within the 31 of October 2018.

In case of equal merit, the prize amount will be divided between the winners.

The Committee will be appointed by the Department's Director with his own decree and will be composed of three members including the verbalizing secretary.

## **ART. 4 – Final Ranking**

The ranking, with the appropriate safeguards of privacy, will be published on the website of the Department of Economics and Finance.

The publication of the ranking will be the official announcement of the results. There is no other form of communication of the awards.

**The ranking will be published by December 10 2018.**

## **ART. 5 – Prize Awarding**

The winners will be notified by an email message sent to the email account provided on Delphi. By 5 days from the notification, the student must formally accept the prize, otherwise we will consider withdrawn his/her position and we will contact the next student in the ranking list.

- copy of the Italian Fiscal Code;
