Course Description

The Course is intended as an Introduction to the historical evolution of European integration, from the early Communities (European Coal and Steel Community, European Economic Community, Euratom) to the European Union.

It presents students with the complexities of the integration process in terms of actors, mechanisms and policies, and reveals its implications for both member states and third countries. At the same time, the course will highlight the connections of the integration process with the wider international context. Finally, the course provides a historical perspective to some major topics of the current debate on European integration, such as euro, single market and fiscal compact; role of European institutions in global governance; enlargement, common foreign policy and EU's international role.

From a methodological point of view, the course aims to familiarize students with theories and historiographical interpretations, as well as with original documentation and terminology related to European integration.

Teaching Method

Lectures; in-class discussion of assigned readings; analysis and contextualisation of original documentation and debate on its content; final in-class simulation of relevant scenarios related to EU's domestic and international issues.
