Training programs and internship opportunities are important to all students to have a more concrete experience of the labour market.

I think that Internships can be more useful, for students, at the last year and with a length of at least 12 weeks; this could give the interns a better understanding of the job and the company and allows the interns to have a more complete experience and to give their contribution.
