



**CALL for n. 4 VISITING POSITIONS  
at the DEPARTMENT in ECONOMICS and FINANCE  
in ACADEMIC YEAR 2024/2025**

-decision of the Board of the Department taken on December 19, 2023 and on March 12, 2024-

The Department of Economics and Finance of the University of Rome Tor Vergata invites distinguished professors, preferably from foreign University, to apply for a visiting position.

The purpose of the Visiting Professorship Program (ViPP) is to raise the University's international profile through the development of teaching and research cooperation.

Tor Vergata welcomes applications for **4 Visiting positions**, as follows:

- n. 1 Long Visiting positions;
- n. 3 Short Visiting positions.

**Visiting Professors: activity and period**

Visiting professors are expected to carry out research activities in cooperation with students, researchers, and professors of the Tor Vergata academic community.

The visitor will formulate a teaching proposal for a series of seminars at the Ph.D. in Economics and Finance over a minimum of two weeks.

- The **Long Visiting Professors** are expected to spend at least four weeks at Tor Vergata University of Rome, and give seminars for 12 hours over at least two weeks. The Department will award an all-inclusive maintenance grant of 6.000,00 euros. Any additional costs will be covered by the visitors themselves.
- The **Short Visiting Professors** are expected to spend at least two weeks at Tor Vergata University of Rome, and give seminars for at least 6 hours. The Department will award an all-inclusive maintenance grant of 4.000,00 euros. Any additional costs will be covered by the visitors themselves.

Applicants are required to indicate in the application the favorite visiting period within the academic year 2024/2025, in Spring 2025 (**January – June 2025**).

Applicants are required to send to [visiting@def.uniroma2.it](mailto:visiting@def.uniroma2.it) an updated CV, the teaching proposal for the PhD series of seminars, and Annex A for the acknowledgment of the privacy policy ("Privacy Policy Disclosure\_n9\_selection and contract assignment").

In case no applications will be submitted or will be suitable for the Long Visiting positions, the Selection Committee can decide to assign the amount of the vacant positions to increase the number of Short positions available.

**Timeline**

The deadline for application is **June 30<sup>th</sup>, 2024, 12:00 p.m.** (Central European Time).

### **Selection**

The available positions are assigned through a competitive selection procedure, carried out by a Selection Committee appointed by the Department of Economics and Finance.
