**Dissemination.** Media articles featuring Luisa Corrado's research were published by CNN International; her research output was also disseminated in Cambridge and widely published through the official University Magazine Research Horizon. Following the presentation at the Royal Economic Society 2007 (Warwick) as headlines in the following: *The Times*, *The Economist*, *BBC*, *Reuters*, *CNN international*, *Daily Mail*, *the Guardian*, *The Daily Telegraph*, *The Independent*, *United Press International*, *EU Business*. She was interviewed by *Reuters*, *the Times*, *the Independent*, *BBC World* and *BBC radio*. The Royal Economic Society also reported the results of presentation in the main conference website. Other newspaper worldwide have published the news: *China Daily*, *The Australian*, *Daily India*, *Corriere della Sera* and many others worldwide. In the recent past there have been similar achievements. After she presented the results of her research at the Royal Economic Society Annual the conference, the paper "Identifying and Interpreting Regional Convergence Clusters" was selected and subsequently published in the 2005 Conference issue of *The Economic Journal*, one of the leading journal in Economics. Since its publication the paper has been subsequently cited in more than 70 other papers in the area and also cited in the *Handbook of Economic Growth* (Durlauf, Johnson and Temple, 2005) as one of the first attempts to provide a joint methodology to identify and interpret regional convergence clubs alongside the new economic geography type of models.

**Awards and Prizes:** In 2008 Luisa Corrado was awarded the Marie-Curie Excellence Award with a top mark of 100/100 with the following motivation: *The candidate is an outstanding young researcher who is working in a field of great interest to the public. She has developed innovative teaching methods in the field of econometrics. Her dissemination of results to the general public and her promotion of science are excellent and make her a model candidate for the Marie Curie Award.* In 2004 Luisa Corrado was awarded a Marie-Curie Intra-European Fellowship EURECON on “Regional Convergence Clusters across Europe: Methodological Issues and Empirical Evidence” at the University of Cambridge for 20 months. The proposal received an overall mark of 85.2% and was evaluated as *excellent*. Following the results a Marie-Curie Fellowship for the continuation of her research with an overall mark of 91/100. **The Marie-Curie Project EURECON is featured in the final report for the 6th Framework Programme by the European Commission as one of the 30 success stories - over 14.000 funded.** Among other Awards and Prizes in 2000 she has been awarded the *Scottish Economic Society Sir Alec Cairncross Prize* for the best paper submitted by new economist at the Royal Economic/Scottish Economic Society Millennium Conference and in 1999 she also received the Prize for the best research awarded by the National Bureau of Research (CNR), Italy. Regional Studies Association 2013 Best Referee Award for the journal *Spatial Economic Analysis*. She is also a *Honorary Member* of the Regional Studies Association for 2013.

**Conference Organised.** In order to promote policy attention on these topics and to disseminate results she has organised a one day workshop in Trinity on 11-th May 2007 on ‘Income and Well-being: Spatial Disparities and Convergence’ under the headings of her host the Faculty of Economics and the Centre for International Macroeconomics and Finance. The workshop did bring together researchers and practitioners who are making contributions in the theory and empirics of spatial and regional economic analysis. Special interest is devoted to the analysis of inequality and convergence of income across nations and regions and the analysis of individual well-being across the EU-15 regions. Luisa Corrado has presented the results of the study on the determinants of individual well-being alongside Prof. Danny Quah (LSE), Prof. Andrew Oswald (Warwick) and Prof. Andrew Clark (Paris). She has also co-organised a second workshop in May 2008 on ‘European Convergence’ always at Trinity College, University of Cambridge (among invited speakers Prof. P. Arestis, Prof. J. Temple, Prof. M. Wickens). She has attended over 50 international conferences and workshops.
